RULES & REGULATIONS FOR ALL VENDORS

- 1. Only those individuals who fill out a complete application, pay the appropriate fee and receive approval from the Selma Parks and Recreation Department will be permitted to display and sell.
- Spaces are provided for the exclusive use of the applicant and only for the activity approved by the Selma Parks and Recreation Department. Spaces will be allotted on a first-come first-served basis. We offer no guarantee that one vendor will have a monopoly on a specific item offered for sale.
- 3. Booth spaces for vendors will be 10' x 10'. Space for food trucks will be 15 feet in length X 10 feet wide. All booth structures must be within the confines of the allotted space. No tables, chairs, electrical cords, water hoses, etc. will be provided. Exhibitors shall position booths so that they will not interfere or obstruct the view of other booths. Spaces will be assigned to contribute to the overall concept of the festival or event.
- 4. No alcoholic beverages are permitted on town property.
- 5. Selma events are sponsored by the Selma Parks and Recreation Department and Town of Selma.
- 6. Exhibitors are responsible for setting up their own booths.
- 7. Booths must be manned during the operating hours of the festival or event.
- 8. All booths are expected to be attractive and in good taste.
- 9. Please keep trash in proper receptacles
- 10. All vendors are responsible for reporting their own taxes.
- 11. No refunds are given for inclement weather. Individual refunds vary with each festival/event, but typically, the cut-off for refunds is 45 days prior to the event/festival.
- 12. The Selma Parks and Recreation Department and the Town of Selma are not liable for any damages, injury, or loss to any person or goods from any cause whatsoever. The Selma Parks and Recreation Department or the Town of Selma is not

responsible for any claims for damage, injury or loss arising out of or in connection with the use of space or grounds in this festival/event.
