The Town of Selma will receive separate sealed formal bids for the FY15/20 CDBG Sewer Rehabilitation/Replacement Project at the **Office of Engineer, WithersRavenel**, located at 219 Station Road Suite 101, Wilmington, NC 28405, until **Tuesday, December 12, 2023, 2:00 pm**, local time, at which time the bids received will be publicly opened and read aloud virtually. Bids received after this time will not be accepted. While there is an option to attend the Bid Opening virtually, hardcopy bids are still required to be received. To participate in the virtual Bid Opening, you must email Kassie Young at [kyoung@withersravenel.com](mailto:kyoung@withersravenel.com) by 10:00 am local time **Monday, December 11, 2023**, to be provided with the information to join the virtual bid opening.

This Base Bid project consists of the rehabilitation of approximately 1,027 LF of 6-inch existing gravity sewer line, 4,637 LF of 8-inch existing gravity sewer line, 356 LF of 10-inch gravity sewer line, and rehabilitation/replacement of approximately 18 manholes. The rehabilitation will include the replacement and reconnection of 145 sewer connections and approximately 4,305 LF of 4-inch sewer laterals. If time and budget allow, the project may include up to five (5) bid alternates in additional areas along 200 Block of W. Noble Street (SR 1900), 100 & 200 Block of E. Watson Street, 300 Block of S. Pollock Street (US HWY 301), 200 Block of W. Preston Street, 100 Block E. Dr Martin Luther King Jr. Way.

A Pre-Bid Conference will be held on **Tuesday, November 28, 2023, at 1:00 pm** local time, Virtually, and at the Selma Town Hall, located at 114 North Raiford Street, Selma, NC 27576. Interested parties are encouraged to attend this conference to review the plans, ask for additional information or clarification, and to visit the project site. Attendance at the Pre-Bid-Conference is highly encouraged but is not mandatory.

Each bid shall be accompanied with a cash deposit or certified check drawn on a bank or trust company insured by the FDIC or a Bid Bond prepared on the form Bid Bond contained in the Bidding Documents or a Surety Company's standard form and property executed by a corporate surety licensed under the laws of North Carolina to execute such bonds. The amount of bid bond shall be equal to five (5) percent of the total of the bid made payable to the Owner.

To qualify, all bids shall be submitted using bid forms contained in the Contract Documents. Incomplete or segregated bids will not be accepted. No bid shall be withdrawn for a period of **90** days after bid opening except as provided in Instructions to Bidders. Bidders must show evidence that they are licensed to perform the work in the Bid Documents as required by the North Carolina General Statutes Chapter 87. The Owner reserves the right to reject any/all bids, to waive formalities, or to reject non-conforming, non-responsive, or conditional bids. The Owner reserves the right to award a contract to the lowest, responsive, responsible bidder or bidders, taking into consideration quality, performance, and time.

This project is a portion of the FY15/20 Community Development Block Grant (CDBG) Infrastructure Program Numbers 15-I-3166 and 20-I-3616 that is financed with \$1,999,809 of CDBG funds (100% of total program cost).

The Owner is an Equal Opportunity Employer and encourages bidding by small, minority and female (M/WBE) contractors and does not discriminate on the basis of race, color, religion, sex, national origin, handicap/disability, age, or familial status. Bids from qualified disadvantaged business enterprise (DBE), historically underutilized businesses (HUB), and Section 3 business concerns (locally owned/operated businesses that provide employment opportunities to low-income individuals) are encouraged. Bidders shall be required to submit with

their Bids affidavits of "Good Faith Efforts" in the recruitment of Minority Businesses. Bidders must comply with the Executive Orders 11246 and 11375, Title VI of the Civil Rights Act of 1964, the Anti-Kickback Act, the Contract Work Hours and Safety Standard Act, and Davis-Bacon Related Acts. The work will be subject to the prevailing wage rates established by the U.S. Department of Labor.
