20240312-4: AN ORDINANCE TO AMEND CHAPTER SIXTEEN OF THE
CODE OF ORDINANCES OF THE TOWN OF SELMA

WHEREAS the Town of Selma Planning Department has initiated text amendments to Chapter 16 of the Town Code of Ordinances to modify provisions of Chapter 16 - Article VIII - Garbage and Refuse Collection and Disposal; and

WHEREAS on the Town Council called for a public hearing at the regularly scheduled Council meeting on February 13, 2024, to discuss the proposed amendments to Chapter 16 (Public Services and Utilities); and

WHEREAS on March 12, 2024, as part of a legislative public hearing the Town Council reviewed the amendments and unanimously voted to amend Chapter 16 (Public Services and Utilities).

NOW, THEREFORE, BE IT ORDAINED THAT:

Section 1. The Code of the Town of Selma is hereby amended as follows:

Chapter 16 - Article VIII - Garbage and Refuse Collection and Disposal - Sec. 16-214. - Construction or demolition of buildings.

(c) Such waste matter and rubbish shall not be placed on the sidewalk or curb for town trucks to move, but shall be moved by the person, contractor, or subcontractor who caused the same to be formed.

(d) Notwithstanding the foregoing, Public Works is authorized to remove waste matter and rubbish not exceeding two knuckle boom scoops being estimated at twelve cubic yards of material. Any garbage bags being disposed of must be placed within the trash receptacles. Garbage bags placed upon sidewalks or curbs is not permitted and will not be collected.

Chapter 16 - Article VIII - Garbage and Refuse Collection and Disposal - 16-216. - Residential garbage collection.

(b) The mobile containers shall be placed within two (2) feet of the curb or street edge or in an accessible location approved by the Public Works Director but shall not be placed in the street. The mobile containers shall have their lids closed flush on the container while holding waste. The containers shall be placed in the required location for collection no earlier than 4:00 p.m. on the day preceding a designated pickup day and shall be removed from the curbside location no later than 8:00 a.m. on the day after the container has been emptied. Except during these hours, the mobile containers and all other refuse containers shall be kept in a location no closer to the street than the front ~~line~~ door of the residence.

Chapter 16 - Article VIII - Garbage and Refuse Collection and Disposal - Sec. 16-222. Violation; penalty.

(d) Notwithstanding subsection (a) of this section, provisions of this article may be enforced through loss of recycling waste collection service privilege and/or additional fees for waste collection services.


Chapter 16 - Article VIII - Sec. 16-224. Prohibited items.

No used tires, construction waste, hazardous waste, industrial waste, land-clearing waste, or appliances of any kind shall be disposed of by placing them in commercial trash receptacles or residential mobile refuse containers, or by placing them at the street for town pickup. All tires and appliances shall be disposed of by the owner in accordance with county regulations and state law or in a manner approved by the Public Works Director. In no event will the Public orks department of the town be responsible for the pickup or disposal of same.


Section 2. The Town Clerk is hereby authorized to insert such amendments into the official CODE OF ORDINANCES OF THE TOWN OF SELMA kept on file in the Office of the Town Clerk.

Section 3. This ordinance shall become effective upon adoption.
